



## Waiver for 2024 NTPL National Championship Events – Hilton Head Island, SC & Las Vegas, NV

### Waiver Text

Liability Release and Waiver, Likeness Release and Waiver, Medical Release, and Safety Acknowledgement. In consideration for being permitted to attend and/or participate in the National Team Pickleball League Championships ("NTPL Championship") operated or hosted by NTPL – a product of Utah Tennis Association, during the 2024 calendar year, and by attending and/or participating in the NTPL Championship, which constitutes an agreement and acceptance to be bound by this Release and Waiver, the Participant and/or the Participant's parent or legal guardian on behalf of themselves and the Participant, (collectively, "Participant"), acknowledge and agree as set forth herein.

LIKENESS RELEASE AND WAIVER. Participant grants to NTPL (Utah Tennis Association), and its related entities, subsidiaries, affiliates, successors, assigns (collectively, "Released Parties") and to such other persons designated or given permission to from time to time by Released Parties, the irrevocable right and permission to use, in any manner, throughout the world, in perpetuity and without compensation, Participant's image (photographic or otherwise), artwork (coloring, pictures, or otherwise), likeness, name, voice, conversation, as well as any biographical information, testimonials, statements and paraphrases of statements that Participant provides to the Released Parties in connection with the Event (collectively, "Participant Content"), either alone or accompanied by other material, in whole or in part, in any media and formats whether now known or later developed, for any purpose relating to developing, promoting, advertising and publicizing the Released Parties, including but not limited to, electronic or non-electronic form or media, print, audio-visual, multimedia, exhibition purposes, internet websites and social media. Participant agrees that any recordings, images, artwork, photographs, film, and/or videotape taken of Participant are owned by Released Parties. If Participant should receive any copy thereof, Participant shall not authorize its use by anyone else. Participant hereby waives all rights to inspect and approve the finished product and materials, their use, or such visual, written, or audio copy as may be used in connection therewith. Participant understands and agrees that Participant has no rights to any royalties, payments, or other benefits derived from any such image. Released Parties shall exclusively own all rights to all materials created by or on behalf of Released Parties that incorporate the Participant's image. Participant acknowledges and agrees that Participant has no right to review or approve any such materials and that Released Parties have no liability to Participant for any editing or alteration of such materials or Released Parties' presentation of Participant. Any credit or other acknowledgment of the Participant shall be determined by the Released Parties at the Released Parties' sole discretion. Participant agrees that Participant will not hold or seek to hold Released Parties responsible for any liability resulting from the use of Participant's name, voice, portrait, likeness, artwork, photograph, and/or motion pictures in accordance with the terms of this Agreement. Participant acknowledges and agrees that the Released Parties are not obligated to use Participant Content.

LIABILITY RELEASE AND WAIVER. Participant waives and releases any, and all rights and claims against the Released Parties for any injury or loss suffered while taking part in a NTPL Championship Event. Acceptance of the Participant's entry into a NTPL Championship Event is without assumption or responsibility of any kind by the Released Parties, host facility, or the management of any event in which the Participant may be entered or may participate. In consideration of the acceptance of Participant's entry, Participant does hereby for and on behalf of myself, my heirs and my legal representatives release and forever discharge the Released Parties, their officers, committees, representatives, employees, coaches, and volunteers, of and from any and all claims and damages, losses or injuries, including, without limitation, the risks of contracting a communicable disease or illness including, but not limited to, exposure to COVID-19, or a bacteria, virus or another pathogen capable of causing a communicable disease or illness, which may be suffered or sustained by me in connection with my activities during the period for which such permission is granted and any period traveling to and from the events described, and all claims are hereby waived and released, and Participant covenants not to sue, therefore. Such waiver and release shall apply to any liability caused in whole or in part by the Released Parties' negligence in connection with Participant's entry or participation in the events.

MEDICAL RELEASE. Participant hereby authorizes the rendering of emergency first aid and any other medical treatment deemed necessary in the event of any injury or illness. Participant agrees that Participant will be responsible for payment for any such medical procedures. Participant hereby agrees to abide by all applicable rules and regulations and codes of the Utah Tennis Association doing business as NTPL

SAFETY. Participant hereby acknowledges that although NTPL requires Event facilities to implement enhanced safety measures and precautions, an inherent risk of exposure to COVID-19 and other communicable diseases or illnesses (including exposure to bacteria, viruses, or other pathogens capable of causing a communicable disease or illness) exists in any public space. Participant agrees that Participant shall at all times follow CDC guidelines and comply with all protocols while Participant is at any of these events.

I, the Participant, have read and understood this Release and Waiver. I understand by signing this Release and Waiver, I have given up substantial rights. I have voluntarily signed this Release and Waiver. I am at least 18 years of age and am competent to contract in my own name. I have read this Release and Waiver before signing below, and I fully understand the contents, meanings, and impact of this Release and Waiver. I agree that this Release and Waiver is intended to be as broad and inclusive as permitted by the laws of the United States and that if any one or more of the provisions contained in this Release and Waiver, shall, for any reason, be held to be invalid, illegal or unenforceable in any respect, the invalidity, illegality or unenforceability, shall not impact any other provision of this Release and Waiver, and this Release and Waiver shall be curtailed, limited or eliminated only to the extent necessary to remove the invalidity, illegality or unenforceability.
